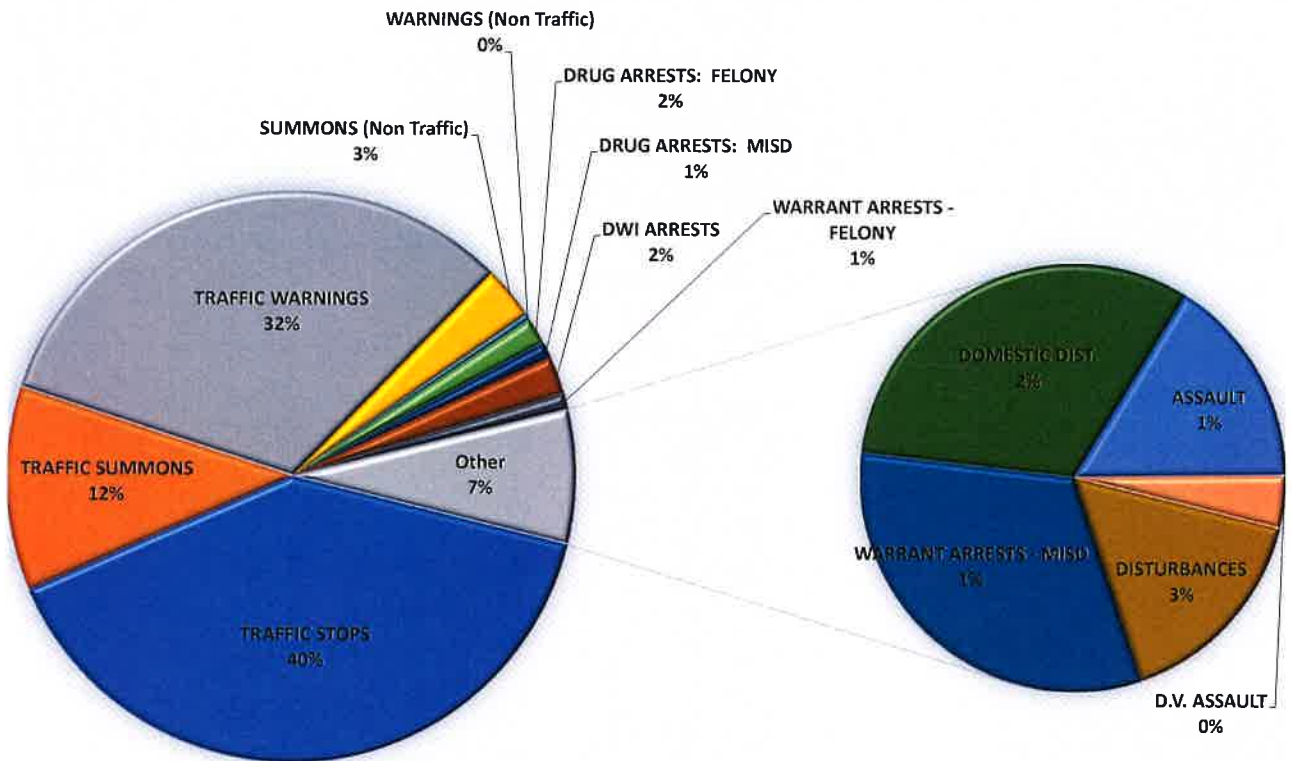

SIGNIFICANT MAY EVENTS

05/03/2021 Officer conducted a traffic stop. Driver was issued summonses for impeding the flow of traffic, possession of drug paraphernalia and driving while intoxicated drugs.

05/03/2021 Officer conducted a traffic stop. The driver was issued summonses for no operator's license, failure to maintain financial responsibility and possession of marijuana. The passenger was arrested on outstanding warrants and possession of marijuana.

An additional charge was added for Possession of Stolen Property.

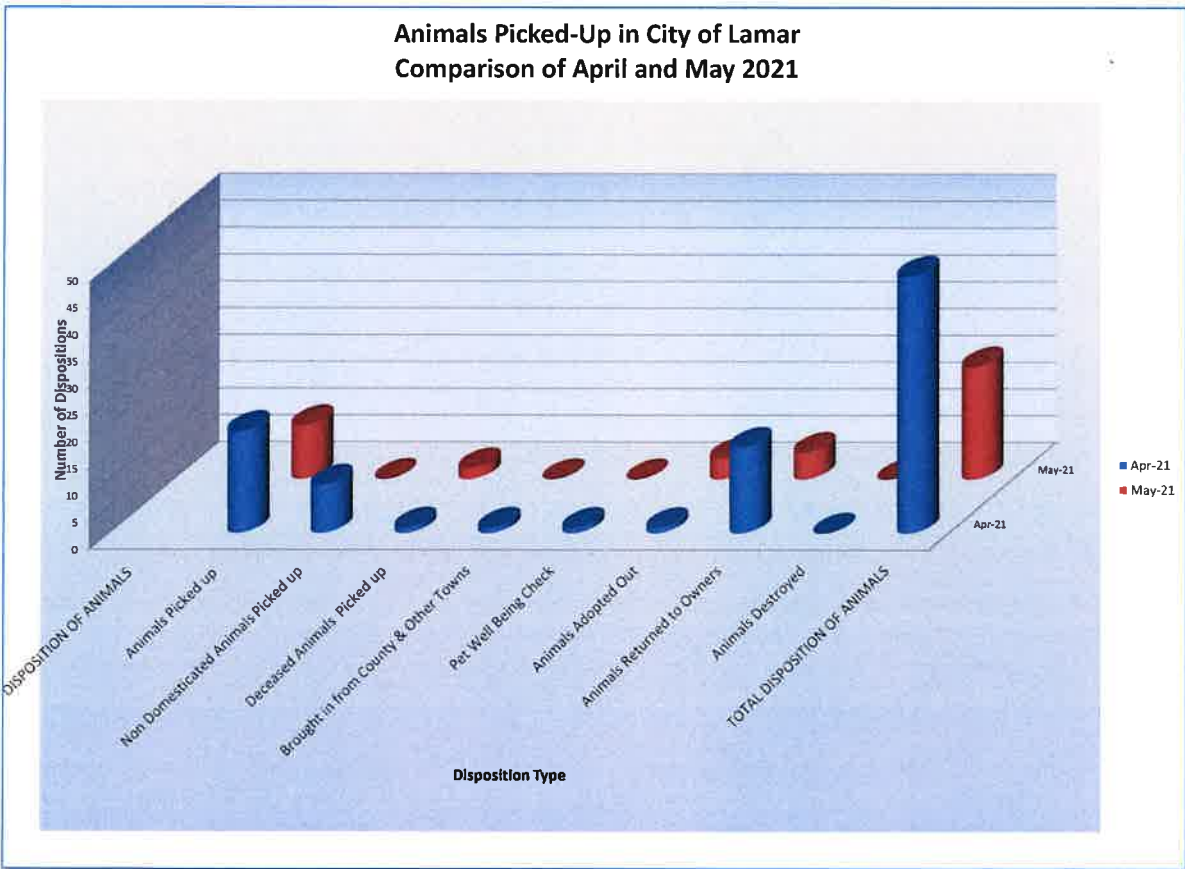
SIGNIFICANT MAY EVENTS (Cont.)

5/26/2021 Was called to the scene of a suicide in the 1000 Block of East 12th St.

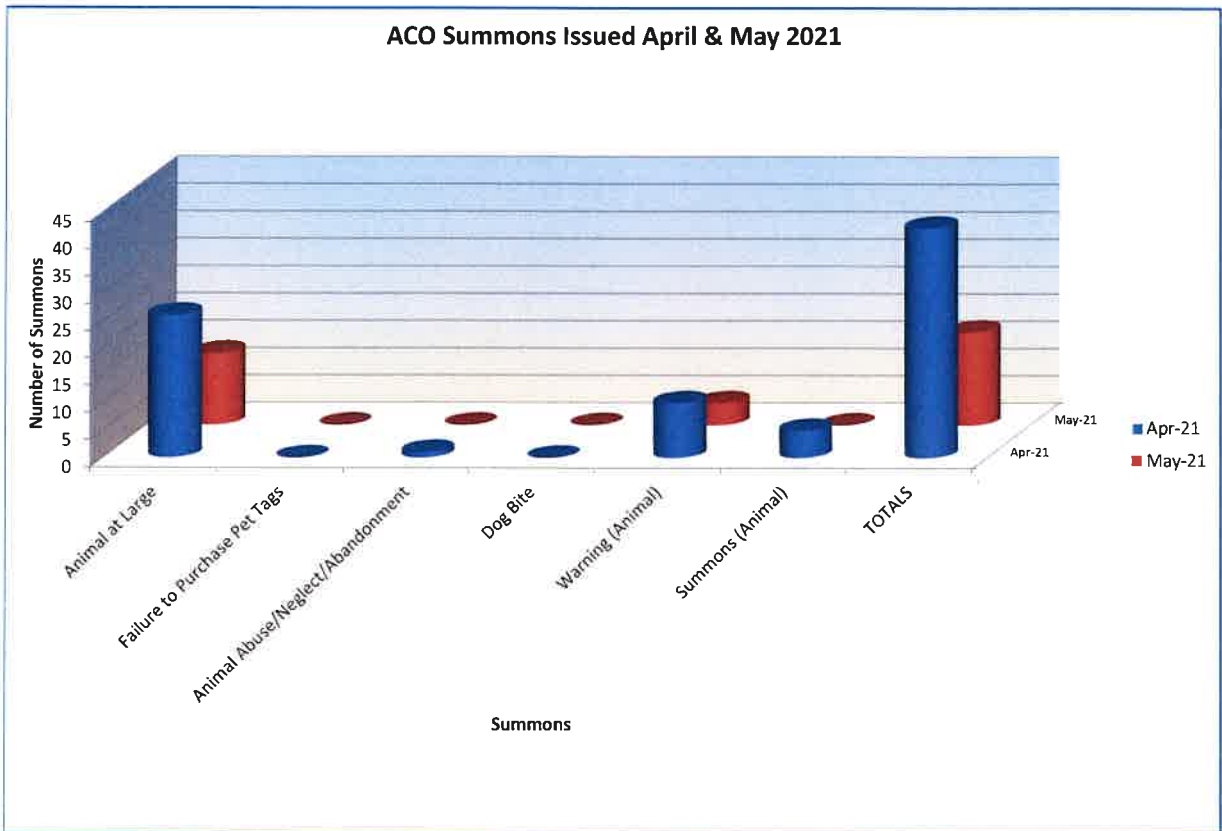
