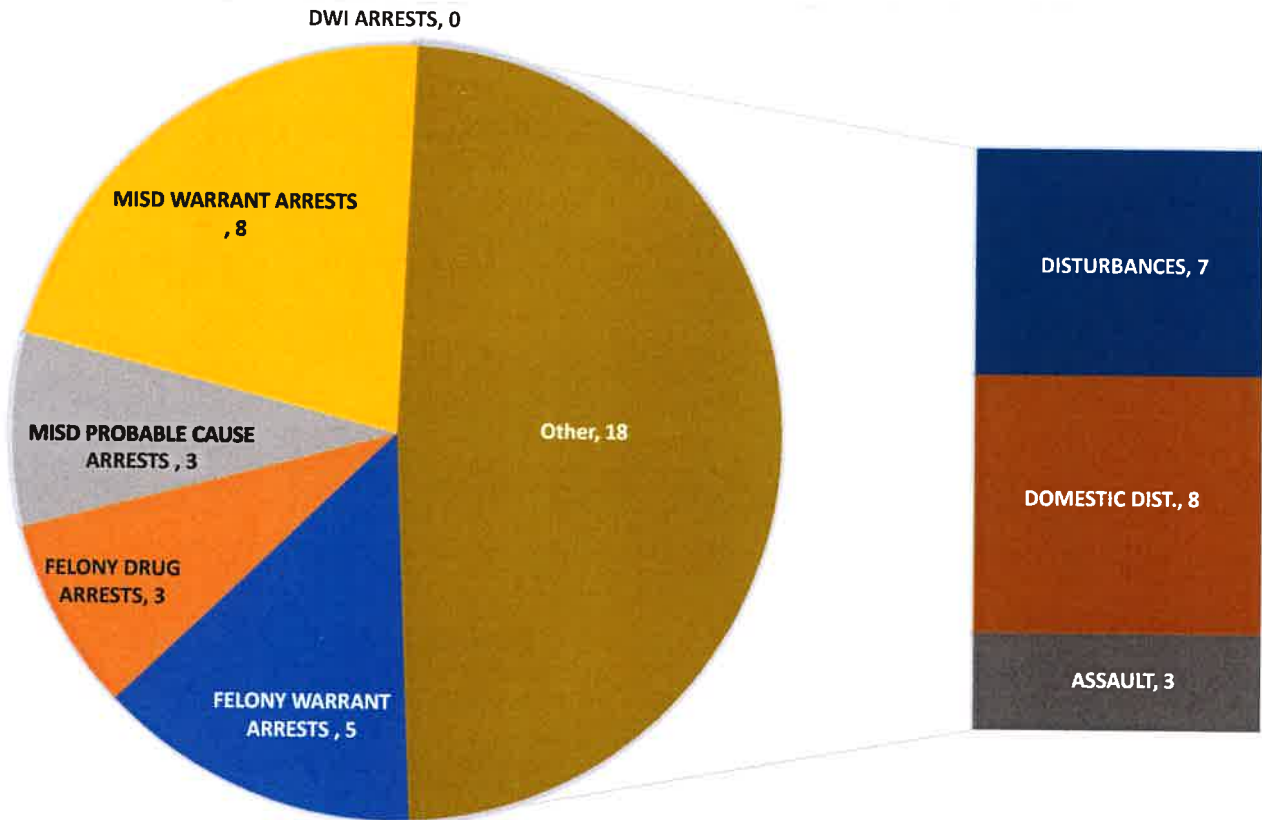

The Police Department is requesting a checking account to keep money that the Police Department has seized; money that is not "actual evidence". Currently the department is storing money in the Police Evidence Room. This is not good practice. Today, standard practice is to keep money seized by the police in a bank account separate from other city money. Money seized that is "actual evidence" (i.e. marked drug money or similar money), will still be kept in the evidence room.

The checking account will be under the control of the city clerk. When the courts release money, or return money to an individual, the city clerk will write a check to the person

SIGNIFICANT FEBRUARY EVENTS

2/4/2022 Officers were dispatched to the 700 block of Maple for a domestic disturbance. Suspect had left the residence but was discovered hiding in a shed at 9th & Gulf St. Charges included Burglary-no force-residence x2 and resisting or interfering with arrest.

2/10/2022 The Lamar Police Department has arrested Michael J Branham, 27, of Lamar MO, after an investigation into thefts of mail packages from front porches here in Lamar. These thefts occurred on February 8th and February 9th. Probable Cause Affidavits have been submitted to the Barton County Prosecutor's office for consideration of charges.

Michael J Branham has been formally charged through the Barton County Prosecutor's office with two counts of Felony Stealing, bond set at \$25,000 each count.

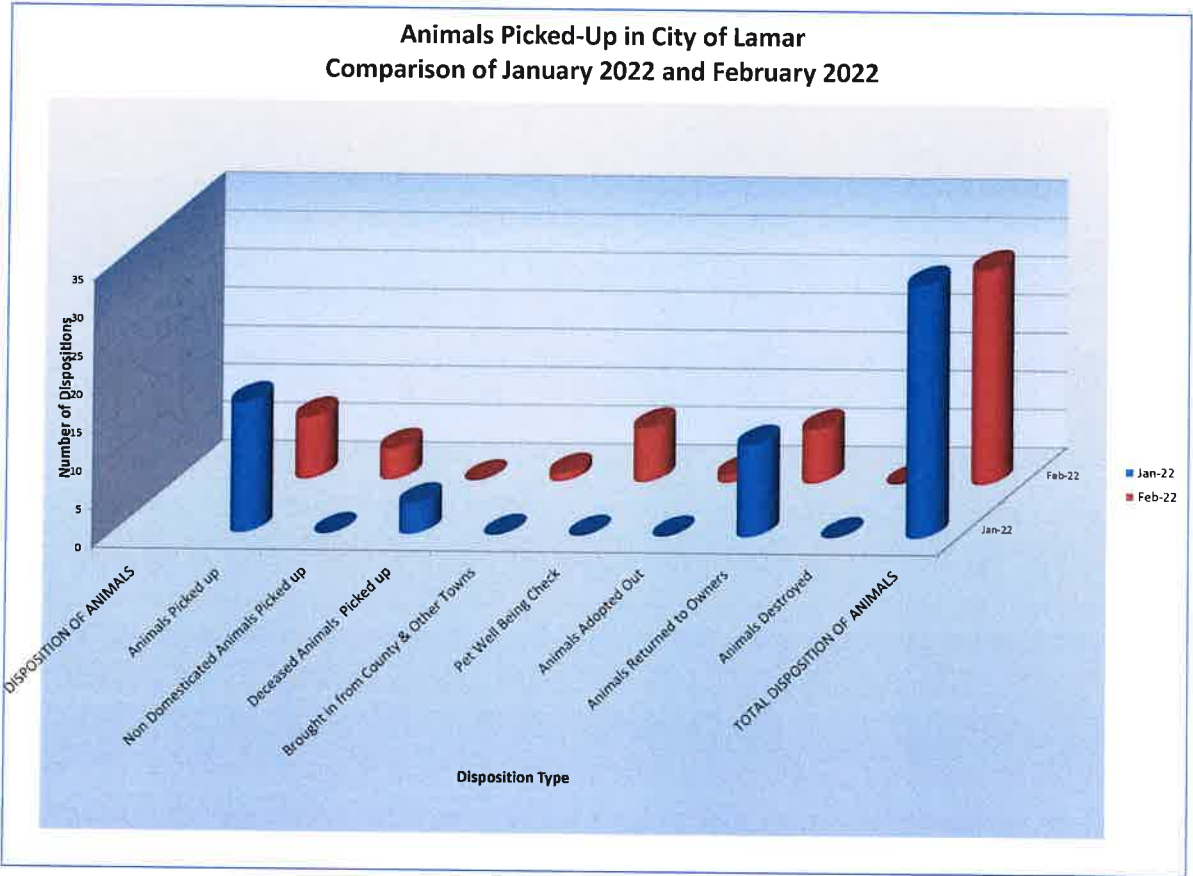

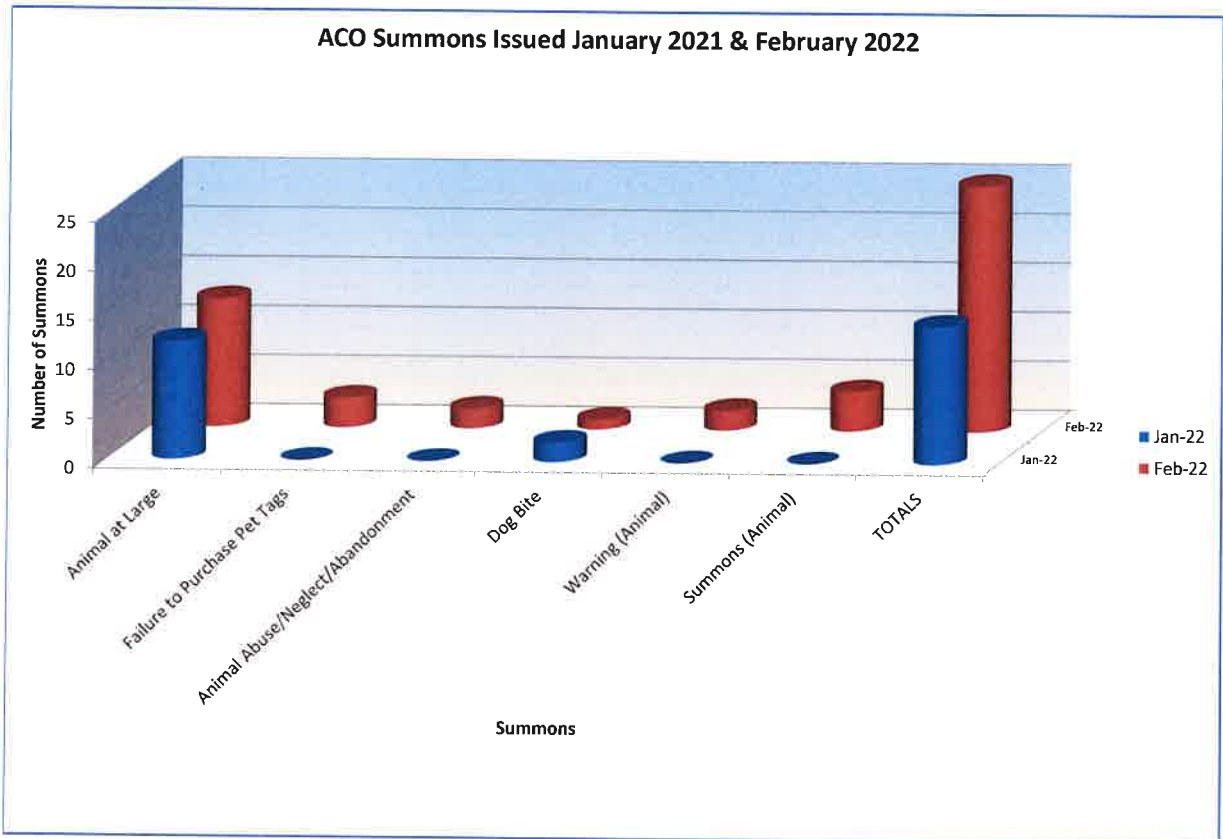
